We will try for a February Code class at this facility. If this facility is not available, Joe Cenzori has been offered a classroom at Parma Town Mall free of charge to the Western Reserve Division from the Parma Fire Dept. The only restrictions are if they are not using it. Most if not all of their events take place during the day so there should be no conflicts with our night courses.

Joe Cenzori will inquire with the BBS to add approval to the list of disciplines already approved for our course to include Fire Prevention Inspectors. They can be an asset to us as well ass we can be an asset to them.
